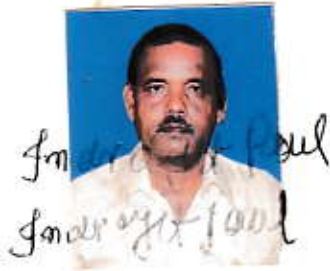

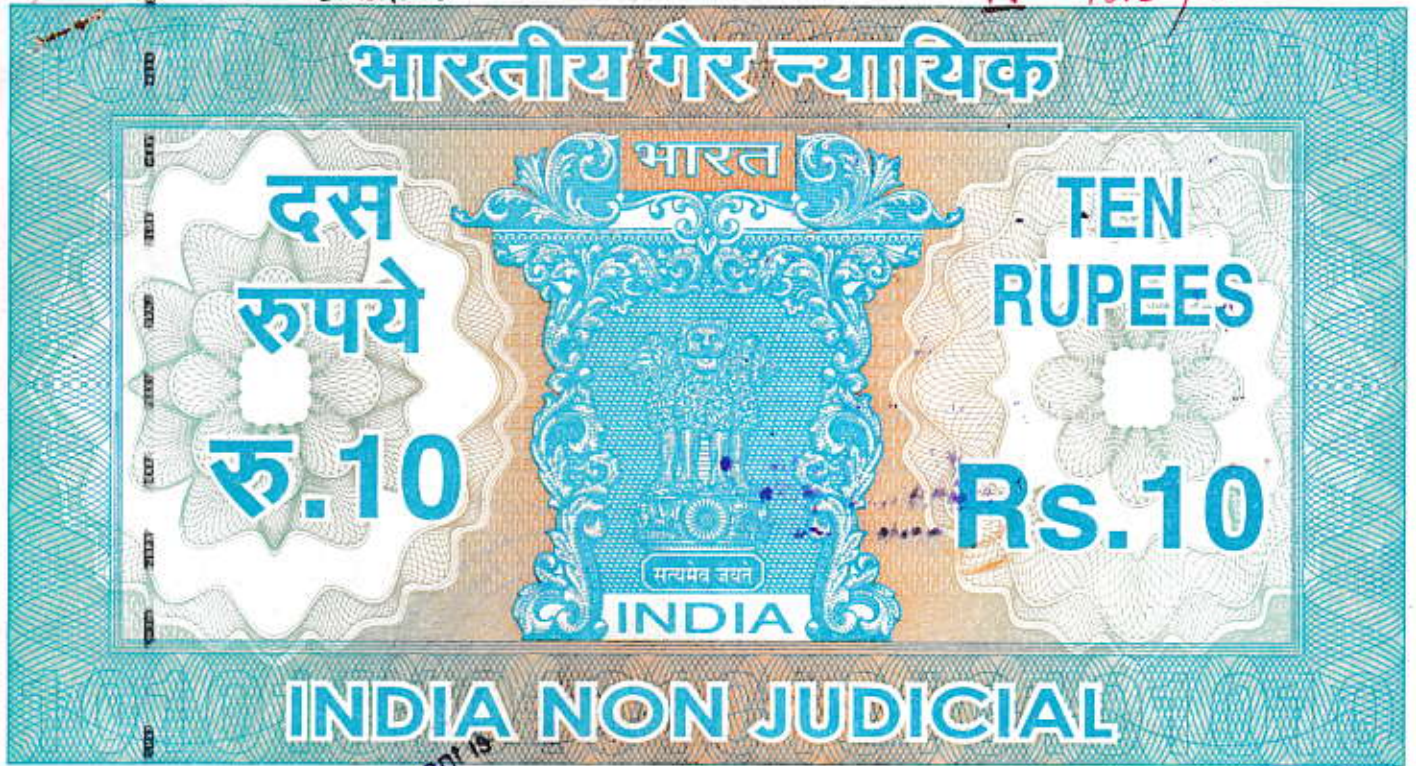

WHEREAS the FOUNDER was desirous of establishing an educational and research trust for purpose of running academic institute of high order with national and international standard i.e. International Research Institute for Deaf (IRID), for the benefit of the people of India, specially the people of Garhbeta Region irrespective of caste, creed, community or religion. An academic and administrative building has been constructed by FOUNDER to help local deaf children in education and research in the field of acoustics.

In the minutes of 35th Trust Meeting of (AFECT), held on 10th March 2013 in the Trust office, a decision has been taken for amendment of aims and objectives of the trust. These decisions are taken by the trust after the death of FOUNDER and after several meetings with the local educationalist and as per their suggestion the trust building with the aims and objectives mainly in academic purpose.

It has been realised that at present International Research Institute for Deaf is not be very practical in this remote area. This is because it involves large amount of finance, costly equipments and highly motivated scientist in this field. The trust is not a position to fulfill these needs. Howerer the trust is interested to contribute in the field of educatoin as per the present need of the locality and within its limitation. Therefore the trust declares a few changes in aims and objectives

of the Trust Deed given in the following paragraph.

1. Charitable Vocational school for deaf with special emphasis on computer education for Class IX onwards, providing speech training with hearing aids/cochlear machine to needy deaf children of this locality and possible medical help to them. The institute also aims to organize medical camps from time to time for these children and regular health awareness program like Yoga, Gym for local people. It is a part of the original aims and objectives of the Trust Deed.

2. Establish a educational institute of high standard preferably CBSE level English medium school having computer and IT facility or any other educational institute as per the need of the people of the area and make it self-sustained; non-profitable organisation in the long run. Such type of school is very important in the rural area as the children are deprived of good education facility. A good academic institute will help the children of this locality to build a better career and become responsible citizens of the country.

The institute aims to provide a platform for holistic development of children through curricular and extra-curricular activities like sports, arts, cultural activities and personality development.

The institute also aims to designing of various innovating and inspiring programs for developing both scientific
