The total number of section of the school shall be restricted to 13 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws 2. The school has uploaded lease deed in place of land certificate, whereas as reported by IC school has running on 4655 sq mtrs of land. However, school has uploaded a fresh land certificate dated 09-10-2021 land measuring 6032 sq mtrs on lease in name of secretary of the school on the school website under mandatory disclosure section. Thus, the school is directed not to remove the same from its website in future. 3. The school has uploaded fire safety certificate which is already expired. However, renewed copy of the same dated 26-06-2021 has been uploaded by school in the mandatory disclosure section on the school website. Thus, the school is directed not to remove the same from its website in future. 4. As reported by IC member school has 5 ft Boundary wall. Further, school has opted the more land on lease as and now running on 6032 sq mtrs of land. Thus, the school is directed to ensure Boundary walls to be constructed/ erected with minimum 6 Feet height from all side and upload the videography of the same on the school website before making school operational. 5. The school is required to set-up all the labs and library as per dimension given in Affiliation Bye-laws and upload the videography of the same on the school website before making the school operational. 6. The school is required to appoint counsellor as per Board norms 7. The school is required to implement the Policy of inclusion for the CWSN. 8. The school is required to develop its play area. 9. The school is required to renew all the mandatory certificates time to time. 10. The school is directed not to remove the videography link in future
